Chairman Attends the Second Convocation of SAU

As the Chairperson of SAU Governing Board, the Chairman of UGC Nepal attended the second convocation of South Asian University held on Monday, 12th June, 2017 in New Delhi. The Ambassador of Nepal to India, Mr. Deep Kumar Upadhyaya, had chaired the convocation as a visitor's nominee. The Hon'ble Minister of State for External Affairs, Government of India, Mr. M.J. Akbar has graced the occasion as the Chief Guest. Mr. Amjad Hussain B. Sial, the recently elected Secretary General of SAARC was also present as a guest of honor along with noted academics, high ranking diplomats and other dignitaries from around the South Asian region. Many members of Governing Board, Executive Council, Academic Council, and Finance Committee along with academics and other dignitaries had attended the convocation.

Prof. Koirala received the Chief Guest and the Chairperson and the visitor's nominee in the Convocation. As the Chairperson of Governing Board, he requested the Visitor's nominee declare the convocation open. The students of

Approval of Programs and Budgets

The Board Meeting of the University Grants Commission held on 9th August 2017 has made the decision to approve the budget and programs for the fiscal year 2017/18 (2074/75) with the total amount of Rs. 9.917915 billion for the operation and capital development of higher education sector. Out of this budget, Rs 1.823 billion has been allocated for the capital development of higher education institutions in the country. It is 18.36% of the total budget while

81.63% has been allocated for the operation. Rs. 6.645 billion has been allocated for Tribhuvan University, which amounts to 67% of the total higher education budget. The Commission has also allocated Rs. 0.65 billion for regular and physical facility development grants to community colleges across the country. The grants will be provided to the community campuses on the basis of formula funding and other set criteria.

two batches were awarded degrees on this occasion. Altogether 185 students-21 from Afghanistan, 28 from Bangladesh, 1 from Bhutan, 1 from Maldives, 16 from Nepal, 11 from Pakistan, 3 from Sri Lanka and 104 from India-received Masters Degrees. Other 9 students received M. Phil Degrees-one each from Sri Lanka, Bangladesh and Afghanistan and 6 from India. Among them, 11 received SAU Gold Medals for their excellent academic performances. One Nepalese student, Mr. Binit Gurung, also received the Gold Medal in MA Sociology.

Likewise, UGC has approved the different programs and activities under the Higher Education Reform Project (HERP) with the estimated cost of Rs. 0.9974 billion for the fiscal year 2017/18. The Commission has been implementing HERP since 2015 with the soft loan support of the World Bank. The aim of this project is to support reforms in the selected institutions for improving the quality, relevance and efficiency of higher education and to assist underprivileged students for equitable access to higher education. The total cost of the project is NRs. 6.5 billion.

UGC allocates grants to higher education institutions for their smooth operation and to help them achieve academic excellence, as it is provisioned by its Act (1993). UGC disburses grants to higher education institutions broadly under two categories: operation grants and capital development grants. UGC funding to universities are provided in the form of block grants and formula based grants. Block grants are provided for the operation and it is calculated on the basis of number of teachers and administrative staffs a university employs; whereas the formula-based grants is calculated on the basis of cost recovery.

Mapping of Higher Education Institutions in Nepal

University Grants Commission has initiated a project of mapping all the higher education institutions (universities, including constituent, community and private campuses) in Nepal. The objective of the project is to show the location and the distribution of higher education institutions using GIS methodology. The mapping further aims to show the exact campus location, total number of students, programs, geographical terrain, access roads, institution's contact information and campus buildings.

To facilitate the project, the Commission has recently formed an expert team of six members led by the Member Secretary of the Commission Prof. Dr. Dev Raj Adhikari. Prof. Dr. Narendra Raj Khanal, Department Head, Central Department of Geography, TU; Prof. Dr. Bhim Prasad Subedi, TU; Prof. Dr. Padam Chandra Poudel, TU; Mr. Dinesh Bajracharya, EMIS Specialist, and Mr. Dul Raj Chimariya, Monitoring and Evaluation Officer of UGC.

Formation of Committees for Intensive Study

University Grants Commission Nepal has recently formed a High Level Committee for the intensive study of the structure, governance and financing of higher education as per the federal structure of the country. The 7 member committee, coordinated by Prof. Dr. Triratna Manandhar, is to submit the report of the study by November, 2017. Prof. Dr. Keshar Jung Baral, Prof. Dr. Ramesh Prasad Bhattarai, Prof. Dr. Shuilu Manandhar, Prof. Dr. Abdul Quiuum, Dr. Hari Prasad Lamsal, and Mr. Subas Chandra Dhungel are the members of the committee.

Similarly, the government of Nepal has formed another committee to suggest for the amendment of the existing Acts related to all the Universities and Health Science Institutes in Nepal. The five member committee coordinated by UGC Chairman Prof. Dr. Parashar Prasad Koirala is also mandated to submit the report of the study as well as the draft of amended acts by November, 2017. Prof. Dr. Abhi Subedi, Prof. Dr. Laxmi Mainali, Mr. Bishnu Prasad Khanal, and Mr. Pratyus Wanta are the committee members.

RMC Feasibility Study Visit

The University Grants Commission has recently completed the feasibility study of Research Management Cells (RMCs) in 18 higher education institutions that have applied for the UGC Grants for RMCs for the FY 2073-74 (206-2017). They included Barun Multiple Campus (Sankhuwasabha), Post Graduate Campus (Morang), Siddha Jyoti Education Campus (Sindhuli), Janta Multiple Campus (Sunsari), Mahakavi Devkota Campus (Nawalparasi), School of Business (Kaski), Institute of Medicine, Pokhara Campus (Kaski), Faculty Research Committee, Faculty of Health Sciences (Kaski), Nuwakot Adarsha Multiple Campus (Nuwakot), Dhawalagiri Multiple Campus (Baglung), Chure Campus (Bardiya), Central Institute of Forestry (Makwanpur), Maharajgunj Nursing Campus (Kathmandu), Janamaitri Multiple Campus (Kathmandu), Saraswati Multiple Campus (Kathmandu), Central Department of Computer Science and Information Technology (Kathmandu), Padma Kanya Multiple College (Kathmandu) and Amrit Science Campus (Kathmandu). UGC teams visited these institutions to inspect the infrastructure and interact with the campus management, faculty members and students and submitted the report to the UGC. The result of grant award is going to be announced soon.

RMC is envisioned as an umbrella structure providing management support to all structures and functions related to research activities in each higher education institution. The research related structures such as Research Committee, Institutional Review Committee, Ethics Committee, Hazard and Safety Committee, and functions like research funding, research capacity development, responsible conduct of research, institutional assurance and compliance come under the RMC.

Each year, UGC allocates certain number of grants to support RMC. There are three kinds of support: 1. Full support for establishing a RMC (Rs. 10,00,000), 2. Partial Support for establishing a RMC (Rs. 5,00,000, and 3. Continuing support for previously supported RMCs (Rs. 2,00,000).

RMC can serve as a structural support for reforming research programs in higher education and the interest in RMC has been growing among faculty members, students and institutions.

Accreditation of Community Campuses

University Grants Commission recently awarded the accreditation certificate of quality assurance to two higher education institutions: Madhyabindu Multiple Campus (MMC), Nawalparasi and College of Biomedical Engineering and Applied Sciences (CBEAS), Kathmandu. MMC is a community campus affiliated to Tribhuvan University and CBEAS is a private college affiliated to Purbanchal University. Likewise, the Quality

Assurance and Accreditation Committee (QAAC) has recommend the UGC board for the accreditation of Saptagandaki Multiple Campus (SMC), Chitwan.

The Peer Review Team (PRT) of MMC was led by Prof. Dr. Jai Raj Awasthi and CBEAS and SMC by Prof. Dr. Shiba Kumar Rai. The number of accredited institutions has now reached 17. However, five previously accredited institutions are in the process of receiving re-accreditation.

Selection of Best Campus for the Education Award

UGC Nepal has selected the two campuses as the best campuses of the year 2073/074 and recommended for Best Campus Education Award to the Ministry of Education. Central Campus of Technology, Dharan (Sunsari) and Kailali Multiple Campus, Dhangadhi (Kailali) were certified for the award. Both are the campuses of Tribhuvan University; Dharan is the constituent campus whereas Kailali is an affiliated public campus.

PRT Assessment

The Peer Review Team assessment of four higher education institutions has been completed, which are also acknowledged as the QAA cycle completed institutions based on the decision taken by QAAC in various dates. The QAA cycle completed institutions are: Global College of Management, Kathmandu; Rupandehi Campus, Rupandehi; Mahakavi Devkota Campus, Nawalparasi and Damak Multiple Campus, Jhapa. The PRT's were led by Prof. Upendra Pradhananga, Prof. Dr. Mahendra Singh, Prof. Dr. Ishwar Prasad Upadhyay and Prof. Dinesh Raj Pant respectively. Once these institutions are able to respond the PRT recommendations generated during assessment, they will stand in a position to get the award of accreditation.

Pre-Visit Assessment

Preparatory assessment visit has been recently completed in 19 institutions including two institutions in re-accreditation process. These institutions are currently working on recommendations provided in a report generated during preparatory assessment visit. Pre-visit assessment completed higher education institutions are as following:
